To: Ananda Marga Members in New York Sector

Namaskar.

This note is a brief summary of and an introduction to the information contained on the attached documents. As you may be aware, in early 2006, the Ananda Marga, Inc. (USA, New York Sector) [AM, Inc.] Board of Directors made unauthorized amendments to the By-Laws/Constitution. That effort of amendments was one of numerous acts by those Board members as individuals and as a body that promoted subordination, factiousness, and falsehoods.

In the four years since, Ananda Marga Pracaraka Samgha (Central) [AMPS] has made efforts to communicate with, and to understand the intentions and desires of, these individuals -- to no avail. Instead, AMPS has noticed an escalation of indiscipline and anti-organizational activities and, in response, has decided to step forward to preserve the integrity and solidarity of the Mission.

Approximately a year ago, the General Secretary of AMPS asked the newly posted Sectorial Secretary, Acharya Vimalananda Avadhuta, to reconstitute the AM, Inc. Board of Directors in order to restore the proper legal and structural framework in the USA and in the Sector as instructed by the AMPS Founding President, our loving Guru Shrii Shrii Anandamurti Ji, through the Ananda Marga scriptures and social codes. The Board has since been reconstituted and the new roster is listed on the attached declaration from the Sectorial Secretary.

A letter from AMPS's legal representative, Gammon and Grange, P.C., was sent today to eleven or twelve Marga members who are known or thought to have held director/officer positions on the previous AM, Inc Board of Directors. The letter simply gives them notice of their removal from the board, some of the reasons behind the action, and it demands the timely surrender of the Corporate assets (and those of its affiliates and subunits) to the new SS, and to the AM, Inc. Board of Directors. The letter also outlines the potential costs if they do not comply within the ten-day deadline, which may include, but not necessarily be limited to, litigation or filing suit in the Court of Law.

It is hoped that there will be no need to file a suit. It will be in interest of all to avoid



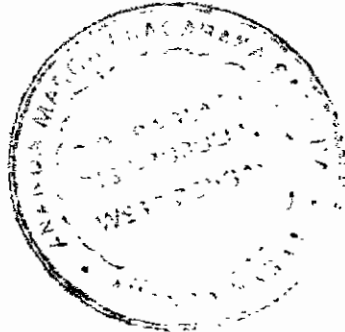
Dear brother,




